What is a Safeguarding Adults Review?

A Safeguarding Adult Review (SAR) looks at how local organisations worked together to safeguard and promote the wellbeing of the adult at risk at the centre of the review. The review will examine how we responded to the adult's individual circumstances and how we engaged with the adult and whether we followed the key principles of Safeguarding in terms of working in partnership to protect and empower the adult at risk and to prevent harm occurring in the future. It may also look at how agencies are working with other adults at risk in the immediate family or in care settings. The review considers what was done, identifies good practice as well as highlighting lessons which can be learned for the future and identifies how we can improve practice. It is not a criminal investigation or public enquiry and its aim is not to place blame but to support continuous learning and improvement.

Why are you carrying out a Safeguarding Adults Review?

The Darlington Safeguarding Adults Partnership Board will carry out a Safeguarding Adult Review whenever an adult at risk¹ has been seriously harmed or has died where abuse or neglect is known or suspected and there are concerns about how agencies worked together to safeguard the adult.

What is the Darlington Safeguarding Adults Partnership Board?

The Darlington Safeguarding Adults Partnership Board (DSAPB) brings together all the main agencies which work in partnership with adults at risk and their families across Darlington to keep them safe. The DSAPB through an accountability process assures that these agencies work together effectively to protect adults at risk of abuse or neglect, take steps to prevent it happening and to respond proportionately when abuse or neglect is suspected. Examples of the agencies involved in the partnership are Police, Health and the Local Authority, but this list is not exhaustive and other agencies contribute to the work of the Board.

Who will carry out the Review?

A panel of professionals will appoint an independent author to review the decision making and understand the context of these decisions. The aim of the review will be to learn lessons from how agencies worked together. The independent author will also ensure the adult at risk and/or their friend/family or advocate are also included in the review. The independent author will prepare a report. This report will say what lessons have been learnt and make recommendations to Darlington Safeguarding Adults Partnership Board.

What will I / we have to do?

You do not have to do anything. However, you will have the opportunity to give your views if you would like to. We will make sure that there is someone who can help you to do this (see back page).

How long will the Review take?

The Board will aim to have the review completed within 6 months of the decision to undertake a SAR.

What will happen after the Report is finished?

The Darlington Safeguarding Adults Partnership Board will write an action plan to ensure improvements are made to the way agencies work together to keep adults at risk safe. Each agency will also be expected to update board on their progress and how their practice has improved.

Who will see the Report?

The completed report will be anonymised and it will be made publicly available via our website. There will be no identifiable information about the adult at risk or the family. It will outline the learning and express recommendations for agencies to consider and act on. Prior to it being made public a representative from the panel or the independent author will meet with you to go through the detail.
